## Confirmation of change to pupil finish time starting September 2025

Friday 6th June 2025


Dear Parents/Carers,

As you are aware, on Wednesday 21<sup>st</sup> May, a parent/carer questionnaire was sent to yourselves to consult on our plans to extend finish time of the school day by 10 minutes. The reasoning behind wanting to make this change was to better accommodate the lost curriculum time now that we have moved to a 2 week half term in October. The 10 minutes, spread over the year, will be equivalent to an extra 30 hours of curriculum time for the children.

Thank you to all of those who took the time to complete the questionnaire of which I can now share the results.


When answering the question, 'Do you support the proposed change to extend the school day by 10 minutes?'
